Digest of quality management and the Deming consists of two parts . First , Avoid the Seven Deadly Diseases . Secondly , Follow Fourteen Principles of Grain Quality (Widodo , 2011; 12) . Both are implemented in sikius Sikius process known as PDCA , namely :

- 1. PLAN: Plan process -oriented quality of customer needs;
- 2. DO: Implement the above with consistent PLAN;
- 3. CHECK: Monitor the course of the process, then do the evaluation for improvement;
- 4. ACT: Integrate the above remedial actions to the Plan at the next cycle Principles of Quality Management as proposed Masaake Imae (Widodo, 2011; 15) is written in his book entitled Maxims 10 QC who later also became a standard reference in the ISO 9001 (Widodo, 2011, 15)

3 RESEARCH METHODOLOGY

- (a) Preparing students to be assets of the nation's noble character, productive and mampi develop themselves sustainably , can adapt and compete face the challenges of the future.
- (b) Cultivating schools and excellent service -based collaboration, synergy towards vocational school.
- (c) Implement education and training in the field of agribusiness, agro-industry, tourism, fashion, culinary, finance, office administration, computer network engineering and automotive lightweight.
- (d) Applying discipline and honesty are based on the soul and spirit of faith and piety. The vision and the mission always instituted against teachers "

Furthermore, the interview with the head of Vocational High School 2 City Prabumulih regarding quality objectives showed the following results:" Quality objectives for each program we do not have it but the expertise to measure the success of the success of the learning process we see from the Tertiary attainment Minimum completeness Criteria (KKM)".

Furthermore, the results of interviews with the deputy principal areas of quality guidelines on the availability of quality / quality manual can result in the following: "Quality guidelines / quality manual we do not have it but we 're doing the preparation of quality guidelines".

Furthermore, the results of interviews with the deputy principal about the availability of RPP curriculum areas can result in the following: "Every teacher who will teach lesson plans are required to have and collect us. RPP collection is done at the beginning of the semester no later than one week before the start of teaching and learning activities

2. Do

Based on the interview with the deputy principal of the curriculum areas of work procedures for teachers in teaching and learning can result in sebagao following: "We have completed the procedures regarding the teaching and learning process, although we feel that existing procedures are not yet complete and representative of all activities.

Procedures such as curriculum procedures , supervision procedures , test procedures and others. In addition we also provide work instructions as semester exams , a national exam and midterms. Furthermore, based on interviews with the Head of administration on the identification of existing documents showed the following results : "We have identified the existing documents such as staffing , student , financial and others , especially in the administration , but for other parts or other work unit identification has not been going well. We also put these documents in cabinets that are protected so that the documents are not easily damaged by air or any other ".

3. Check

Based on the interview with the deputy principal about the quality field pegawasan it can result in the following: "In the implementation of our learning process monitoring, supervision in the form of supervision. Supervision - supervision we do through senior

teachers who have been at or by the appointed school superintendent to the teacher . The supervision of the BE activity periodically . We also have supervisory procedures "Furthermore, based on interviews with the principal about the surveillance program can work in the following results: "We are always implementing and monitoring the successful implementation of the work program . In addition we also hold meetings on the implementation of the work program and the learning process on a regular basis , at least 1 month . The activities we conduct to ensure adherence to the program of work and learning process in order to keep it running properly and in accordance with rules and predetermined plan . Besides these activities also to evaluate any obstacles encountered and how where how to solve."

From the interview can be summed up as follows:

- (a) Implementing and monitoring the successful implementation of the work program.
- (b) Hold meetings on the implementation of the work program and the learning process on a regular basis, at least 1 month
- (c) This activity is conducted to ensure adherence to the program of work and learning process in order to keep it running properly and in accordance with rules and predetermined plan.
- (d) This activity is also to evaluate what are the obstacles faced and how where how to solve.

4. Action

Based on interviews with the principal regarding the corrective actions taken showed the following results: "From the results of meetings of the learning process as well as implementation of a work program, we conduct an evaluation, the results of this evaluation we issued a recommendation in case of flaws or how to overcome the obstacles that exist, so that improvements can be made . We are also constantly monitoring the implementation of the recommendations that we give, the slope provide recommendations usually are binding to be implemented ".

Based on these results we obtained the following results:

- (a) The results of the meetings of the learning process and the implementation of a program of work, carried out an evaluation, the results of this evaluation the recommendation issued by the Principal, addressed to all elements of the school based on their respective duties.
- (b) Do supervise the implementation of the recommendations made, recommendations are usually binding to be implemented
