Suggestions which would improve the quality of the paper but are not essential for publication: The article is in principle interesting, but is hard to read and understand in its current form. Instead of listing some detailed comments, the overall general comment is, that the paper is too verbose and too long.

To illustrate the major comment, this reviewer will list below some comments for sections 1, 2, and 3.

Section 1.

What is the triple bottom line? Please explain.

Information exchange has driven change in logistics. Why is this important in the context of the paper?

The noun research is singular. The corresponding verb should also be singular.

Why are the concepts natural resources consumed, waste produced, proportion of waste being treated considered to be technical barriers, as stated in the subsequent sentence?

Why has IT been chosen to improve environmental performance? There are many factors in an organization that influence environmental performance. This must be made more clear. Section 2.

The role of IT in improving environmental performance is not convincing.

The statement: ... by transforming their IT hardware/software including IS cannot be understood. It is a large step from contribution to business operation and innovation to environmental performance.

It has been stated without justification, that improving IT resources helps to improve environmental performance and that adopting IT capability is sufficient. However, there is only one case:

Philipson. The other case, about data centres, is not supporting the author's argument.

This section can be dramatically shortened and structured. It would be good to introduce environmental performance as well as IT capabilities (now in section 3). Furthermore, the relationship between the two concepts should be made more clear.

Section 2 should actually be a literature review and concept choice for this paper.

Section 3 should introduce the framework used.

Section 3.

The choice for RBV has insufficiently been justified.

This section is hard to understand and follow and is way too verbose and long.

This section seems to be a collection of summaries of several studies. The paper, however, is not, or should not be, a summary of relevant studies.

The authors need to choose another way of presenting the content.

Now they present authors:

- author A said this
- author B said that
- author C said yet another thing

etc. with often overlapping content. Now, the reader should do the work of searching for this overlapping content.

The authors, however, should do the work of searching for overlapping content.

They should present the relevant content and refer to authors, like:

... content X (author A, author B). By contrast, content Y (author C), etc.

They should then end with the choices they make.

Somehow the choice are in the paper, but hard to distill.

I advise the authors to rewrite, restructure, and shorten their paper and resubmit.

Suggestions which would improve the quality of the paper but are not essential for publication: Suggestions for improvements are listed in Section 2 below.

Changes which must be made before publication:

This paper attempts to establish a quality profile for IT organisations on how well they can perform in specific country's industry environment. The paper is well written and has solicited extensive literature review.

Four competencies are proposed based on literature reviews in these areas: (H1) Environmental IT Competence, (H2) Human Resources Competence, (H3) Business Process Digitisation, (H4) IT Infrastructure Quality. Two of the competencies, H2 and H3 are hypothesised as "positive and significant", while H1 and H4 are just "positive". The arguments leading to these hypotheses do not show any difference indicating that competencies H2 and H3 will cause "significant" impacts. The authors need to explain why such a difference exists.

The term significant is actually not defined. Apart from no obvious indication, what constitutes a perception of "significance" is unknown. Is >50% impact (also again relative to what?) significant? A more scientific, measureable definition is required.

The research methodology indicates using "survey method". It sounds like a questionnaire is used. Why is it not explained as a questionnaire?

The "research construct" is divided in Table 2 as 19 items. It is not clear if these are translated into 19 questions, or 19 headings (in which several questions are grouped under a heading).

The questionnaire uses a 5-point Likert scale. This means maximum for each question is 5. Why is the mean of the items greater than 5? E.g. EIT1 has a mean of 5.53.

The sub-heading of 5.1 has a typo.

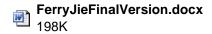
