- > *** Weak aspects: Comments to the author: what are the weak aspects of the paper?
- 1) Why not use the title: "A Literature Review of IT Infrastructure Capabilities in Shared e-Government Concept in Indonesia".
- 2) There are many grammatical error and typos
- 3) The paper is not well organized, so there are many inappropriate paraphrases and non-flowing paragraphs.
- 4) Problem statements described in the Introduction are unclear and focused.
- 5) To obtain originality, complete the study with one or two related works and compare them.
- 6) Give a brief description of the method to support the purpose of the study.
- 7) I suggest, heading of "Literature review method" should be replaced with "methodology"
- 8) Explain what are the objects of this literature review. It is recommended to include definitions of the terms used.
- 9) Follow the template used (IEEE style), such as alignment for paragraphs, heading, etc.
- 10) The paper should review more recent literature (last 5 years).
- 11) In conclusion, the research suggests the framework or concept of better strategies and policies for continuous e-government development in Indonesia. There is no section found in this paper that describes a framework or a concept of those strategies.
- > *** Recommended changes: Recommended changes. Please indicate any changes that should be made to the paper if accepted.
- 1) Fix all errors in this paper according to the note of weakness above.
- 2) Use help from English language expert or grammar tools.
- 3) Improve this paper so that it is better organized and comfortable to read
- 4) Make the keywords more specific.

- There are still some grammatical errors and words writing errors, such as "approarch" in the last line of the Literature review.
- -The literature review is too short to show the state of the art of the research.
- The authors do not have consistency in writing, as in the sriting of Figure 1 in the paragraph, and Fig. 1 in the name of the figure.
